4. How We Collect Your Data

We gather personal information via the following channels:

 as enhancing customer experience or promoting our services), as long as your rights do not
 override those interests.

7. Sharing Your Data

- Legal or law enforcement authorities when required to comply with legal obligations or to protect our legal rights.

All third parties are legally obliged to manage your data securely and in accordance with data protection legislation.

8. Data Retention

We keep personal data only as long as necessary to achieve the purposes outlined in this Privacy Policy or as required by law. Usually, this means we retain your data for up to seven years after our last interaction, in accordance with AML and professional duties.

9. Your Rights
